**MANDATORY CONDITIONS****Premises Licence No: AT/PR/B782LP/01/50063**

No supply of alcohol may be made under the premises licence:

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The admission of children to the exhibition of any film is restricted by age classification awarded to the film by the British Board of Film Classification.

Where-

the film classification is not specified admission of children must be restricted in accordance with the recommendation of the licensing authority.

- "children" means under 18.

- (1) Where individuals are at the premises to carry out a security activity such as door supervision, each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in subsection (1) requires such a condition to be imposed:
  - (a) in respect of premises within paragraph (8)(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c12) (premises with premises licence authorising only plays or films), or
  - (b) in respect of premises in relation to-
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section:
  - (a) "security activity" means an activity to which paragraph 2 (1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

**CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE**

I have undertaken my own risk assessment to take the following proposed steps.

The types of regulated entertainment proposed materially do no more than reinstate the normal pub entertainment that was previously unregulated. No new steps have been identified in relation to the four licensing objectives save as below.

- Any person exercising a security activity (as defined by paragraph 2(1)(a) of schedule 2 of the Private Security Industry Act 2001) shall be licensed by the Security Industry Authority.
- Such a person will be employed at the premises at the discretion of the designated premises supervisor/holder of the Premises Licence.
- Any person as defined in condition (1) will clearly display his name badge at all times whilst on duty.
- No customers apparently carrying open bottles upon entry shall be admitted to the premises at any times the premises are open to the public.
- Where CCTV is installed with recording facilities such recordings shall be retained for a period of 30 days and made available within a reasonable time upon request by the police.
- Alcoholic and other drinks may not be removed from the premises in open containers save for consumption in any external area provided for that purpose.

No further risks have been identified which need to be addressed, save as below:

- To comply with the reasonable requirements of the fire officer from time to time.
- To comply with the reasonable requirements of the building control officer.

No further risks have been identified which need to be addressed, save as below:

- Where appropriate, prominent, clear and legible notices shall be displayed at all exits requesting the public respect the needs of local residents and to leave the premises and area quietly.
- Noise or vibration shall not emanate from the premises so as to cause a nuisance to nearby properties.

The restrictions set out in the Licensing Act 2003 will apply. No unusual or additional risks of harm to children have been identified. No films or videos of any description will be shown so that they can be viewed by persons under the age of any applicable BBFC/Local Authority certification. Children under the age of 16 shall not be permitted to enter the premises after 21.30.

The licence also authorises licensable activities in addition to the times overleaf as follows:-

Until 01.00 following Friday, Saturday, Sunday and Monday of Bank Holiday Weekends – this is May Day, Spring/Whitsun Bank Holiday, Easter, August Bank Holiday

Until 01.00 following Christmas Eve and Boxing Day; from 1000 new years eve to the terminal hour on new years day immediately following.

Alcohol may be sold to persons temporarily residing at the premises or their bona fide guests at any time for consumption on the premises – guests of the residents can purchase only for consumption on the premises.

In the case of recognised international or national sporting events broadcast outside permitted hours, upon 7 days written notice to the Licensing Authority and Police of the event and the times of intended opening, the Licence would authorise licensable activities during those times provided the Police had not served on the DPS written notice giving representation against the event. In the case of the Secretary of State making an Order regarding recognised national or international events under the Licensing Act 2003 its Regulations, such conditions as appear in the Order will supersede this condition.

The licence authorises only the sale of alcohol both indoors and outside, all other permissions are restricted to indoors.
