Fly Tipping Progress Report

1 Summary

1.1 This report provides Members with an update on progress on the action plan for tackling fly tipping across the Borough. The report informs members of the results of consultation on the review of the Fillongley Public Spaces Protection Order 2017 and recommends that the order is renewed for another three years.

Recommendation to the Sub-Committee

- a That Members note the progress report and the updates for the action plan included with the report; and
- b That members consider the results from the consultation for the review of the Fillongley Public Spaces Protection Order 2017; and agree to renew the order for another three years.

2 Consultation

2.1 Consultation has taken place with the relevant Members and any comments received will be reported at the meeting.

3 Background

- 3.1 The Sub-Committee have received regular progress reports on the action plan for tackling fly tipping across the Borough. The last report was prepared for the meeting held in March 2021. This is a follow up progress report to inform Members of further work carried out on the agreed action plan to tackle fly tipping.
 - 3.2 An action plan has been prepared which reflects the multi-agency approach that is being taken by the Council together with Warwickshire County Council, Warwickshire Police, Warwickshire Fire and Rescue Service and Parish and Town Councils.

4 Progress Report

- 4.1 During the COVID 19 lockdown period and restrictions there has been an increase in fly tipping across the borough. During April 20 to March 202 a total of 1462 fly tips have been cleared compared with 1214 over the same period last year. These have been cleared within an average of 0.92 days in the 2020/21 year.
- 4.2 An update for each of the agreed actions is shown at Appendix A. Some of the key headlines include the following:

4.3 **Investigations**

- 4.3.1 The Pollution Team of Environmental Health investigate fly tipping where evidence is available. They have 111 incidents for the 2020/21year period that are logged for investigation. Work on the investigations will start as soon as demands from the pandemic become more manageable and staffing levels are increased. Some PACE Police and Criminal Evidence (Act) interviews have been carried out face to face and some by post.
- 4.3.2 The Streetscape Division continue to deploy CCTV cameras in hot spot locations. The cameras deployed are a mixture of mobile data enabled and non-data enabled. A new type of mobile data enabled camera has been purchased which will upload images and video to the cloud. In-camera storage space, which is an issue, can also be managed remotely.
- 4.3.3 CCTV warning signage continue to be deployed to hot spot locations and following requests from the public.
- 4.3.4 In the March report it was highlighted that since August 2020 Streetscape deployed CCTV cameras at 11 locations. The cameras captured over 10,000 photos and almost 9000 videos. During this time 4 cameras were unfortunately stolen.
- 4.3.5 Since the previous report in March, Streetscape have put out cameras in 6 additional areas, resulting in 17 sites being covered during the last year. During this period one of the cameras was stolen. The cameras have helped provide evidence of 4 fly tipping cases which has been sent to Environmental Health for investigation. In the past 4 months Streetscape have collected and viewed over 20,000 photo images and 16,000 videos.
- 4.3.6 Streetscape have also viewed CCTV footage from a landowner whose land is regularly fly tipped on. This case is proving to be an on-going problem and is being considered with Warwickshire Police to identify options for investigation and enforcement. Crime prevention options have been considered at the location which is impacting into a watercourse.

4.4 Identifying Hot Spots

- 4.4.1 The location data for fly tipping incidents continues to be collected and collated. Between April and March 2020/21, a total of 1172 incidents of fly tipping were cleared across the Borough.
- 4.4.2 The fly tipping reported incident data has been analysed by the Warwickshire Insight Service as in previous years. Attached at Appendix B is a copy of the 2020/21 Parish Fly Tipping Analysis report. The report shows an increase in fly tipping of a total of 1,171 fly-tipping incidents recorded between April 2020 and March 2021, an increase of 72 incidents compared to the last report published in May 2019 (1,099 incidents).
- 4.4.3 Of the 1,073 mapped incidents. The top five parishes with fly-tipping hotspot areas are in Atherstone, Hartshill, Arley, Coleshill and Mancetter parishes. The key findings from the analysis report are:
 - A total of 1,171 fly-tipping incidents were reported between April 2020 and March 2021.
 - Coleshill, Atherstone, Hartshill and Arley are in the top 4 most affected parishes for fly-tipping in the borough.
 - Other Household Waste continues to be the main 'primary waste type', with 374 fly-tipping incidents, 32% of the total
 - There were 115 cannabis-related fly-tipping incidents, 9.8% of total incidents.
 - The majority of cannabis-related fly-tipping incidents were recovered in Corley (15), Fillongley (14), Arley (12), Coleshill and Hartshill (both 11)
- 4.4.4 The current operational hot spot locations include the following:
 - Hartshill Apple Pie Lane, Woodford Lane, Grange Road and Oldbury Road.
 - Atherstone, Alder & Heather Court flats by bin stores (Borough Council).
 - Ridge Lane, Arden Forest Estate bin stores (Borough Council).
 - Corley, Burrow Hill Lane
 - Arley/Shawbury, Daw Mill Lane
 - Arley Tippers Hill Lane Bournebrook watercourse.
 - Marston, Old Kingsbury Road
 - Lea Marston, Hams Lane
 - Grendon, Waste Lane
 - Grendon, Folly Lane
 - Dosthill, Rush Lane. Mainly on private land, however it is visible from the public highway.
 - Wood End, Lower House Lane. On private land. Landowner has recently barricaded the entrance with large concrete blocks.
 - Wishaw, Blind Pit Lane on the corner of road cannabis waste.

5 Multi Agency Approach

- 5.1 The action plan that has been prepared reflects the joint approach attempting to address the fly tipping problems which are currently being experienced across the Borough.
- 5.2 A separate meeting has been held with representatives from the Environment Agency and the National Farmers Union together with the North Warwickshire Inspector for Safer Neighbourhood Policing and the Rural Crime Officer. The meeting was arranged to build upon some recent close working on waste sites and fly tipping. Several actions were agreed at the meeting including the following:
 - NWBC and Police to check the follow up and sharing of information on identified vehicle registrations which don't match with the DVLA registered keepers.
 - NWBC to prepare additional communications regarding the duty of care responsibilities to raise more awareness with the public. Options for targeted messages in hot spot areas are available.
 - Police to arrange when possible multi agency operations to carry out vehicle checks in hot spot areas.
 - All to consider promoting the SCRAP campaign and following the good practice identified.
 - NFU and NWBC to consider scope for requesting funding from the Warwickshire Police & Crime Commissioner after the May 21 elections to support private landowners to remove and deter fly tips.
 - NWBC to consider scope for deploying dummy CCTV cameras at risk locations.
 - Environment Agency to consider further sharing of intelligence about large scale waste dumping and illegal waste sites in Warwickshire.
 - Environment Agency to share information about the proposed tyre marking scheme being considered in West Mercia and other regional areas.
 - Fire & Rescue to share intel about the burning of waste as seen in the borough of Rugby.
 - NWBC to feedback on the enforcement practices being carried out by Nuneaton & Bedworth BC using an enforcement company.
 - Police to consider scope for patrols to stop vehicles using flat beds at night.
 - NWBC to consider scope for issuing Fixed Penalty Notices for inadequate or incomplete Waste Transfer documentation.
 - NWBC and Police to consider scope for a network of CCTV to cover hot spot locations in the Hartshill area.
 - NWBC and Police to consider any additional measures for Boggs Farm in Coleshill.
 - NWBC to consider the use of the cameras with tracker device added.
- 5.3 The intention is to arrange regular meetings with the wider partners to work together on tackling fly tipping and illegal waste sites. The SCRAP campaign is an example of good practice used in Hertfordshire and other areas and includes a tool kit of campaign materials relating to the scraping of fly tipping.

Work to implement the good practice of the SCRAP campaign will be arranged and will build upon some of the communications plan work that has been implemented in North Warwickshire. The actions identified above can be incorporated into an updated action plan for the 2021/22 year.

6 Fillongley Public Spaces Protection Order 2017

- 6.1 At the meeting of the Sub Committee held in March 21 members agreed for consultation to be carried out as part of a review of the Fillongley Public Spaces Protection Order 2017. The order restricts access to the highway in Didgley Lane and Bunn Lane Fillongley.
- Work to prepare the required consultation for the review of the order was carried out. Attached at Appendix C is a summary of the responses to the consultation. The consultation was launched on 29 April 2021 for a six week period.
- 6.3 The consultation was carried out with specific statutory consultees including Warwickshire Police, Warwickshire County Council, Warwickshire Fire & Rescue Service, residents and businesses within the vicinity of Didgley Lane and Bun Lane, Fillongley Parish Council and the Warwickshire Access Group. A public survey link was made available on the Council's website. A total of 119 residential addresses were sent a letter regarding the consultation.
- The consultation results show that 8 responses supported the proposal and one didn't. The feedback from the consultation includes specific comments which are shown on the summary at Appendix C. Fillongley Parish Council have confirmed their support for the order to continue. The Inspector for the North Warwickshire Safer Neighbourhoods Team and the Rural Crime Officer has commented on the order as follows "I would support the continuation of the order, especially in the current climate and the recent increase we have seen in this area across the county and North Warwickshire. From a police perspective the installation of the PSPO has made a significant difference and we would support its extension."
- 6.5 Members are requested to consider the results of the consultation and agree to the extension of the Fillongley Public Spaces Protection Order 2017 for another three years in line with the existing Variation (No1) order 2018. The order is allowed under provisions in the Anti-Social Behaviour, Crime and Policing Act 2014. If the order is agreed an updated version will be published on the website.
- 6.6 Work on other potential locations for a similar order will be arranged when possible as agreed at the March meeting of the Sub Committee. The locations proposed for consideration include the following:
 - Access road off Tamworth Road Polesworth B5000 multi incidents of large scale tipping of tyres at this location in 2020/21.
 - Ryefield Lane Wishaw regular fly tipping hot spot location.

7 Additional Resource Allocation

- 7.1 The additional allocation of funding made in the 2017/18 year to address fly tipping has been used to provide the barriers, gates, CCTV and associated equipment and additional staff hours in Streetscape.
- 7.2 Additional expenditure on security cameras and equipment, publicity campaigns, investigations and multi-agency operations is being planned currently. The spend during 2020/21 has been limited due to the current COVID 19 related restrictions. A spend of £3,924.68 has been made on additional security cameras, associated equipment and costs associated with an abandoned trailer at Middleton.
- 7.4 Consideration is taking place currently about the use of a different type of security camera which includes an inbuilt GPS tracker device. This camera has been used in responding to rural crime problems in Warwickshire and uses 4g and cloud technology. An initial quote for a camera is £278.00. There will be a tariff charge for the 4g which is expected to be approximately £20.00 per month based upon our recent deployments. A firm order will be raised with the intention of purchasing 4 cameras initially.

8 **Summary**

8.1 The action plan to tackle fly tipping has been prepared to reflect joint working with other partners to provide a co-ordinated approach to an increasing problem across the Borough. Members are requested to note the progress made and consider the proposed changes to the current action plan.

9 Report Implications

9.1 Financial Implications

9.1.1 Expenditure of £3,924.68 in the 2020/21 year was funded from the earmarked reserve balance of £30,281.67. This leaves a remaining balance of £26,356.99 for the 2021/22 year onwards. Spend so far is totalling £97.47 in the current year. The balance was created from a one-off allocation of £50,000 towards addressing fly tipping set aside in the 2017/18 financial year. The cost of collecting and investigating fly tips is currently included within the budgets for amenity cleaning and environmental health.

9.2 Safer Communities Implications

9.2.1 These are set out in the report.

9.3 Legal Data Protection and Human Rights Implications

9.3.1 Fly tipping is an offence under the Environmental Protection Act 1990. There is also a Duty of Care specified in this Act which requires producers of waste, including householders, to take all reasonable measures to ensure that their waste is only transferred to someone who is authorised to transport or dispose of it. Public Spaces Protection Orders can be made under the Anti-Social Behaviour Crime and Policing Act 2014 and can prohibit activities which have a detrimental effect on the quality of life in a locality if the necessary consultation has been carried out and responses, and evidence, are

supportive of doing so. Of practical relevance, if a PSPO is made in relation to an area of highway then, again provided that the appropriate consultation has taken place, the Order may allow barriers to be placed to prevent access to the highway concerned.

- 9.3.2 The Council must carefully evaluate the responses received, together with evidence of the incidents of unlawful activities in deciding whether to make or extend an Order. The Council must be satisfied that the activity concerned:
 - (a) is, or is likely to be, of a persistent or continuing nature,
 - (b) is, or is likely to be, such as to make the activities unreasonable, and
 - (c) justifies the restrictions imposed by the order.
- 9.3.3 The use of the security cameras is subject to a protocol to ensure compliance with the relevant legal requirements for CCTV surveillance. The protocol has been reviewed as required to comply with the General Data Protection Regulation and updated guidance prepared by the Surveillance Camera Commissioner.

9.4 Environment and Sustainability Implications

9.4.1 Tackling fly tipping will make positive contributions towards improving the environment and sustainability. The fly tips create adverse impacts on the local environment and use significant resources in removing them and carrying out investigations.

9.5 **Health Implications**

9.5.1 By reducing fly tipping the quality of life in local communities will be improved. This will reduce the adverse impacts on the local environment and local communities.

9.6 Risk Management Implications

9.6.1 There are risks associated with the removal of fly tipping which often include hazardous materials. For example, waste including asbestos requires the use of specialist contractors to remove and dispose of the material safely. The operational risks associated with fly tipping are covered by Streetscape and Environmental Health risk assessments and safe systems of working. The risks associated with the draft action plan have been assessed. There has been a challenge raised about restricting access to the lanes if the consultation on implementing a public spaces protection order is approved.

9.7 Equality Implications

9.7.1 There are no known adverse impacts on any of the groups defined in the Equality Act 2010 under the protected characteristics. The adverse impacts of fly tipping on the local environment is often in rural locations although not exclusively.

9.8 Links to Council's Priorities

9.8.1 The proposed action plan will contribute towards the priorities of creating safer communities and protecting our countryside and heritage.



Overview

There have been a total of 1,171 fly-tipping incidents recorded between April 2020 and March 2021, an increase of 72 incidents compared to the last report published in May 2019 (1,099 incidents). A total of 1,073 records have been mapped due to 98 incidents either having had no co-ordinates being recorded in the data received, or incorrect co-ordinates recorded, resulting in the incident being placed elsewhere on the map. Therefore, these incidents are rendered un-mappable.

The map below shows the main hotspot locations for fly-tipping in North Warwickshire.





Of the 1,073 mapped incidents. The top five parishes with fly-tipping hotspot areas are in Atherstone, Hartshill, Arley, Coleshill and Mancetter parishes. The breakdown of where the 1,073 incidents have been recorded is provided in Table 1 below, with Coleshill, Atherstone, Hartshill and Arley being the top four parish locations with the highest records of fly-tipping.

Other household waste was the most common type of waste found with 374 incidents (Table 2). Construction or demolition or excavation waste was the second highest Primary Waste Type with 181 incidents, this was closely followed by black bags - houshold waste with 166 incidents. A table of the number of incidents by waste type in each parish can be found in Appendix 1.

November 2020 was the busiest month for fly-tipping with 141 reported incidents, followed by 121 incidents in January 2021 (Table 3).



Cannabis Hotspots – Overview

There were a total of 115 cannabis-related fly-tipping incidents recorded between April 2020 and March 2021 in the borough; with 105 incidents being mapped (see below).



This is a reduction of 40 incidents compared to the previous period reported (April 2018-March 2019), although increases were seen in some areas (Table 4).

Of the 115 incidents recorded, the most affected areas were in Corley parish (15) followed by 14 incidents in Fillongley, 12 incidents in Arley and 11 each in Coleshill and Hartshill (Table 4).

Main Fly-Tipping Parishes and Hotspots

Atherstone Parish



There were 149 fly tipping incidents in this parish, with no recorded cannabis incidents.

There are 2 main hotspots within this parish – at the corner of Friary Road and at the corner of Princess Road and Bank Road.

Hotspot 1 - Bank Road



There were 36 incidents in this hotspot, the majority of which were household goods, and white goods.



Hotspot 2 – Friary Road



There were 20 incidents in this hotspot around Friary Road. Again they were household waste and white goods. No cannabis related fly-tips were found.

Hartshill Parish



There were 139 fly-tipping incidents in Hartshill – 35 black bag household waste incidents, 29 Other household waste incidents.

There were 11 cannabis incidents in this hotspot.



Hotspot 1 - Woodford Lane



There were 36 fly-tipping incidents on Woodford Lane. There were 17 incidents of black bags household waste having been fly tipped. There construction were 7 and demolition incidents.

Hotspot 2 - Grange Road



There were 21 incidents on or around Grange Road. most common of these were construction and demolition waste (10). Green waste (3) was also found as well as tyres and asbestos.



Arley Parish



There were 90 fly-tipping incidents in Arley spread around the area: 21 construction and demolition incidents, and 20 other household waste incidents. 12 were cannabis related.



Coleshill Parish

There were 85 fly-tipping incidents in this parish and 11 incidents where cannabis-related materials were recovered.



Main Coleshill Hotspot



There were 14 fly-tipping incidents on Packington Lane. Construction and demolition waste accounted for 4 of the incidents. There were 3 incidents of Other Unidentified waste. Also found were black bags of household waste, vehicle parts and other household waste.



Mancetter Parish



There were 75 fly tipping incidents in Mancetter, none were cannabis-related.

Hotspot 1 – Laurel Gardens, Church Walk



There were 21 fly tipping incidents around Church Walk and in Laurel Gardens. The most common incidents were of other household waste (11). There were also 5 incidents of white goods.



Hotspot 2 – Ridge Lane, Arden Forest Estate



There were 23 incidents on Ridge Lane, and around the Arden Forest Estate. 17 of these were other household waste.



Cannabis Hotspots

Corley



There were 15 cannabis related fly tips in Corley, the main spots being around Burrow Hill Lane and Rock Lane.



Fillongley

There were 14 cannabis related fly tips in Fillongley, 3 of them were grouped on a track between Sandy Lane and Wood End Lane.



<u>Arley</u>

There were 12 cannabis related fly tips in Arley dotted around the area.





<u>Hartshill</u>

There were 11 cannabis fly-tipping incidents in Hartshill, 9 were mapped to be around Oldbury Road.



NORTH WARWICKSHIRE BOROUGH COUNCIL (Didgley Lane and Bun Lane, Fillongley) PUBLIC SPACE PROTECTION ORDER 2017

North Warwickshire Borough Council ("the Council") in exercise of its powers under Section 59, 64 and 72 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act") hereby makes the following Order:

- 1. This Order may be cited as the North Warwickshire Borough Council (Didgley Lane and Bun Lane, Fillongley) Public Space Protection Order 2017
- 2. The Order shall come into operation on 6th November 2017 and shall have effect for 3 years thereafter, unless varied or extended by further orders under the Council's statutory powers.
- This Order relates to that part of Didgley Lane and Bun Lane as shown edged red on the attached Plan ("the Restricted Areas").
- 4. Except as provided in Article 5 of this Order, the effect of this Order is to restrict, at all times, vehicular access onto and along the Restricted Areas identified in Article 3 of this Order.
- 5. The restriction provided by Article 4 of this Order does not apply to any occupier of premises adjoining or adjacent to the Restricted Areas or to any person engaged on Council business, to any police, ambulance or fire service personnel acting in pursuance of statutory powers or duties, to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Restricted Areas or to any person authorised in writing by the Council.
- 6. This Order authorises the installation of horse friendly vehicle barrier which will enforce the restriction at the locations marked 1, 2, 3 and 4 on the attached Plan.
- 7. Responsibility for the maintenance of the horse friendly vehicle barrier at all four locations will lie with Streetscape, North Warwickshire Borough Council, The Council, House, South Street, Atherstone, Warwickshire, CV9 1DE.
- 8. The Council is satisfied on reasonable grounds that the conditions set out in Sections 59, 64 and 72 of the Act have been satisfied and that it is in all the circumstances expedient to make this Order for the purposes of reducing fly-

tipping in the Restricted Areas. The Council makes this Order because flytipping in the Restricted Areas has had a detrimental effect on the quality of life of those in the locality. The effect or likely effect of this is of a persistent and continuing nature as to make this unreasonable, and justifies the restrictions imposed by this Order.

- 9. It is an offence for a person without reasonable excuse to contravene the restriction provided by Article 4 of this Order. A person guilty of an offence is liable to a Fixed Penalty Notice up to £100 or on summary conviction to a maximum fine not exceeding level 3 (£1,000).
- 10. If any interested person desires to question the validity of this Order on the grounds that the Council had no power to make it or that any requirement of the Act has not been complied with in relation to this Order, he or she may apply to the High Court within six weeks from the date on which this Order is made.

- This Order may be cited as the North Warwickshire Borough Council (Didgley Lane and Bun Lane, Fillongley) Public Space Protection Variation (No 1) Order 2018
- 2. The Variation Order shall come into operation on 9th October 2018. The Original Order, as amended by the Variation Order, will cease to have effect after the expiry of three years from the date the former was made, unless varied or extended by further orders under the Council's statutory powers.
- 3. This Order relates to that part of Didgley Lane and Bun Lane as shown edged red on the attached Plan ("the Restricted Areas").
- 4. Except as provided in Article 5 of this Order, the effect of this Order is to restrict, at all times, vehicular access onto and along the Restricted Areas identified in Article 3 of this Order.
- 5. The restriction provided by Article 4 of this Order does not apply to motorcycles, pedal cycles, mobility scooters (or other invalid carriages) or horse-drawn carriages, any occupier of premises adjoining or adjacent to the Restricted Areas or to any person engaged on Council business, to any police, ambulance or fire service personnel acting in pursuance of statutory powers or duties, to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Restricted Areas or to any person authorised in writing by the Council.
- 6. This Order authorises the installation of horse friendly vehicle barrier which will enforce the restriction at the locations marked 1, 2, 3 and 4 on the attached Plan.
- 7. Responsibility for the maintenance of the horse friendly vehicle barrier at all four locations will lie with Streetscape, North Warwickshire Borough Council, The Council, House, South Street, Atherstone, Warwickshire, CV9 1DE.


- 8. The Council is satisfied on reasonable grounds that the conditions set out in Sections 59, 64 and 72 of the Act have been satisfied and that it is in all the circumstances expedient to make this Variation Order for the purposes of reducing fly- tipping in the Restricted Areas. The Council makes this Variation Order because fly-tipping in the Restricted Areas has had a detrimental effect on the quality of life of those in the locality. The effect or likely effect of this is of a persistent and continuing nature as to make this unreasonable, and justifies the restrictions imposed by this Order.
- 9. It is an offence for a person without reasonable excuse to contravene the restriction provided by Article 4 of this Order. A person guilty of an offence is liable to a Fixed Penalty Notice up to £100 or on summary conviction to a maximum fine not exceeding level 3 (£1,000).
- 10. If any interested person desires to question the validity of this Order on the grounds that the Council had no power to make it or that any requirement of the Act has not been complied with in relation to this Order, he or she may apply to the High Court within six weeks from the date on which this Order is made.

North Warwickshire Community Safety Partnership Update

Report of the Chief Executive

1 Summary

1.1 This report provides Members with an update on recent activities with the North Warwickshire Community Safety Partnership. The report includes information about progress with the agreed priorities from a Strategic Assessment 2020/21 and latest crime statistics.

Recommendation to the Sub-Committee

- a That Members consider the update and identify any areas for further scrutiny and consideration; and
- b Members note the revised North Warwickshire Community Safety Partnership Plan 2021/22.

2 Consultation

2.1 Consultation has taken place with the relevant Members and any comments received will be reported at the meeting.

3 Background

- 3.1 The Sub-Committee has previously received reports from the North Warwickshire Community Safety Partnership regarding progress with the actions included in the partnership plan. The last report was received in March 2021.
- Attached at Appendix A is a copy of the April to March crime statistics for the 2020/21 year and attached at Appendix B is the quarter 4 Community Safety Performance Monitoring Report for the 2020/21 year.

4 Overview

- 4.1 The quarter 4 performance report shows the following position, comparing back over the last 12 months:
 - Violence Against the Person and Sexual Offences has increased by 53 offences over the last 12 months. A slight downward trend from the quarter 3 position.
 - Violence with injury has reduced by 62 offences. This is continuing the downward trend from guarter 3.
 - Violence without injury has seen an increase of 127 offences. This is highlighted as a main risk area with increases in malicious communications and stalking and harassment offences.
 - The levels of violence with injury relating to domestic abuse have reduced by 45 offences. Continuing the downward trend from guarter 3.
 - The levels of violence without injury relating to domestic abuse have increased by 31 offences. This is a consistent level with quarter 3.
 - The levels of acquisitive crime have reduced by 281 crimes. A reduction of nearly 35% overall. Reductions have been seen in vehicle crimes, residential burglary and personal robbery. The levels may see a return to previous levels following any lifting of the current lockdown restrictions.
 - The number of reported anti-social behaviour incidents have increased by 732 more incidents compared to the last 12 months. This is a 54% increase. Quarter 4 saw an upward trend. The reports are considered still to be highly influenced by the current lockdown restrictions. Nuisance related reports account for 49% of the increase and environmental reports account for 37%. The latest Strategic Assessment highlights the increases being a countywide trend. Some of the increases are from neighbour disputes. Warwickshire Police are currently carrying out a review of how reports of anti-social behaviour are recorded and processed.
 - The numbers of fatal or serious injuries from road traffic accidents is 40 during April to March 2020/21.
 - Total recorded crime is down by 421 crimes 4295 crimes in total compared to last 12 months. This is showing a downward trend most notably in the last two quarters. Some increases may be seen following the lifting of the lockdown restrictions in the new year.
- 4.2 The influence of the coronavirus restrictions and lockdowns on the crime and disorder figures is still being seen.
- 4.3 The quarter 4 report includes a ward level table of total recorded crimes, the priority crimes of violent crimes and serious acquisitive crimes. The table shows that all recorded crimes have decreased apart from in three wards. The increases in the wards of Baddesley and Grendon, Atherstone Central and

Hurley and Wood End total 20 extra crimes. The increases are due to violence against the person offences. The increases seen in the Curdworth and Hurley and Wood End wards have been clarified and they are mainly due to reports from an individual premise and a specific residential address.

- 4.4 The Inspector for North Warwickshire has advised that serious violence is reviewed daily by the force and trends or issues addressed through a management meeting. The long-term issues are picked up at the Problem-Solving meetings. Nothing of significance has been identified to date for North Warwickshire. The violence is reviewed monthly and if there is anything that stands out as needing addressing this is raised. Sometimes one incident, can create several crimes, which often accounts for rises and would have to be considered when reviewing the statistics. Violence against the person has risen across the county and this is in part due to the lock down and the increase in lower level offences being reported, but also from increased scrutiny all forces are facing for ensuring that they are adhering to the Home Office crime recording rules.
- 4.5 The increases in anti-social behaviour incidents in the wards of Arley and Whitacre, Dordon and Hurley and Wood End have also been clarified. The increases are related to mainly nuisance reports and can be identified to a small number of repeat addresses and some specific locations.
- 4.6 Business crimes have continued to see decreases compared to the last 12 months in guarter 4.

5 Partnership Plan 2020/21 - Quarter 4 Updates

- 5.1 Attached at Appendix C is a spreadsheet showing the individual partnership plan updates which have now been collated. The priorities for the plan include violent crime, crime in rural areas, serious acquisitive crimes and road safety.
- 5.2 Some key headlines to highlight from the partnership and the plan updates from the four quarters of 2020/21 include the following:
 - The Police and Partners Problem Solving Plans are being considered monthly. The meetings are being held using Microsoft Teams. The current plans include actions on public reassurance regarding the Kirby Glebe Farm site, responding to increasing reports of off-road bike nuisance, community impacts from public sex environments, and developing a plan for youth related anti-social behaviour and violence at Abbey Green Park in Polesworth.
 - Warwickshire Domestic Abuse Counselling Services continue to provide their services using telephone and other technology options. During the year 78 referrals have been received for North Warwickshire. The referrals were slightly lower than the 87 seen in the 2019/20 year. The reduction should be considered in the context of the difficulties presented during the lockdown restrictions.
 - The level of domestic abuse related violence with injury offences is 35%.

- Operation Alarity has reduced the level of activity of county lines drug dealing.
- The overall levels of anti-social behaviour incidents have increased with a significant influence of the lockdown restrictions. The current Strategic Assessment for North Warwickshire shows that recorded volumes have been significantly higher this assessment period across North Warwickshire Borough, and indeed countywide, with ASB at an all-time low last assessment period and increases this period being a direct result of the COVID-19 pandemic, as breaches of lockdown conditions were recorded as ASB.
- The multi-agency anti-social behaviour tasking and case management meetings continue to be held using Microsoft teams. The latest meeting in May has seen some new case management plans discussed. The North Warwickshire Inspector for Safer Neighbourhoods is taking a direct input into a Police review to improve their input and co-ordination of responses to anti-social behaviour. This will ensure a consistency in how the Police operate across Warwickshire. This should enhance the local working arrangements.
- Increases in the reports of off-road bike nuisance are being seen. Across the borough there are several hot spot locations which are being monitored. The Police Off Road Bike Team do carry out patrols in the hot spot locations when possible. The team is being supported by the local Safer Neighbourhood Team and promotion of the Dob Em In Initiative. A Policing operation, Operation Array is being developed to respond to the increased reports. This will be supplemented by increased promotion of the Dob Em In scheme.
- The work of the Business Crime Advisor is developing a number of initiatives including the Shop Kind campaign, It won't happen to me workshop for sme's, modern slavery task group and supporting businesses to sign up to a business pledge and a Police Cyber Alarm initiative.
- The Cyber Crime Advisor is supporting cyber security safety awareness campaign, working with Youth Justice regarding out of court disposals and on line safety for young people and raising awareness with Compass about drug related activity associated with social media and the risks posed to young people.
- Work on the review of the Street Cruising Injunction is being considered following a judgement on a national case on injunctions against persons unknown.
- The findings and recommendations from the 2021/22 Strategic Assessment have been considered at a Responsible Authorities Group meeting on the 25 February 21.

5.3 Community Safety Grant 2021/22

- 5.3.1 The Police and Crime Commissioner has confirmed the allocations to the Warwickshire Community Safety Partnerships. Following discussions with representatives of the partnerships across Warwickshire a co-ordinated response to the reductions was agreed. The allocation for the North Warwickshire Community Safety Partnership is as expected to be £22,469.00 a reduction of £9,922.00 from the 2020/22 allocation of £32,391.00.
- 5.3.2 The community safety grant will support the following allocations:

5.4 Safer Warwickshire Officer

5.4.1 The partnership is aiming to support the pilot of the Safer Warwickshire Officer in North Warwickshire. An initial allocation of funding of £5,000 from the community safety grant allocation in 2021/22 has been made to help deliver specific initiatives arising from the work of the new role. Work on recruiting to the post has been delayed. The Warwickshire Chief Fire Officer is currently confirming the overall budget commitment for the post from Warwickshire County Council, Warwickshire Police, Warwickshire Police and Crime Commissioner and other partners. Further updates on the proposal will be reported to the Sub Committee.

6 Partnership Plan 2021/22

- 6.1 The North Warwickshire Community Safety Partnership has a statutory requirement to prepare a Partnership Plan based upon the findings of the annual Strategic Assessment. The existing Partnership Plan has been reviewed and updated in line with the agreed priorities and recommendations identified in the 2021/22 Strategic Assessment.
- 6.2 The North Warwickshire Responsible Authorities Group has agreed the priorities and is due to consider the updated Partnership Plan at its meeting on the 23 June.

6.3 Attached at Appendix D is the proposed Partnership Plan 2021/22. Members are requested to note the plan and provide any comments to feedback to the North Warwickshire Community Safety Partnership.

7 Summary

7.1 Members are requested to note the report and the progress updates provided by the North Warwickshire Community Safety Partnership and identify any areas for further consideration.

8 Report Implications

8.1 Finance and Value for Money Implications

8.1.1 The reduction of £9,922.00 in the 2021/22 community safety grant for North Warwickshire will make it more difficult to support individual community safety projects.

8.2 Safer Communities Implications

8.2.1 These are set in the report and the appendices.

8.3 Legal, Data Protection and Human Rights Implications

- 8.3.1 Community Safety Partnerships were introduced by the Crime and Disorder Act 1998 and most recently amended by the Policing and Crime Act 2009. It is a requirement that the Council works with the police, the fire and rescue authority and the county council to implement a strategy for the reduction of crime. The recommendations in this report and the revised partnership plan contribute to the discharge of that requirement.
- 8.3.2 The deployment of CCTV and ANPR cameras are subject to several legal provisions, including the Protection of Freedoms Act, General Data Protection Regulation, Human Rights Act and others. The deployment is also subject to guidance prepared by the Information Commissioner's Office and the Surveillance Camera Commissioner.
- 8.3.3 The Council is required to have a Committee that scrutinises the crime and disorder work of various organisations within the Borough. The Council has decided that this Committee will fulfil that requirement.

8.4 Environment and Sustainability Implications

8.4.1 By working to reduce crime and disorder, the partnership is contributing towards improving the quality of life for residents, businesses and visitors to North Warwickshire.

8.5 **Health Implications**

8.5.1 The work of the partnership has several synergies with contributing towards healthier communities. These include tackling violent crime, supporting victims of domestic abuse, tackling alcohol and drug misuse and reducing anti-social behaviour.

8.6 Risk Management Implications

8.6.1 The Community Safety Partnership Strategic Assessment includes risk analysis of risk and harm. The analysis uses an adapted Association of Chief Police Officers' Model (ACPO 3 PLEM). This is a basis scoring matrix for levels of harm. The assessment also includes consideration of a Management of Risk in Law Enforcement (MORILE) matrix. The key risks for the partnership are identified within the strategic assessment prepared each year.

8.7 **Equality Implications**

8.7.1 The work of the partnership includes several activities which contribute towards equality objectives. These include support services for victims of domestic abuse, reducing repeat victimisation, monitoring of hate crimes and rehabilitation of offenders.

8.8 Links to Council's Priorities

8.8.1 The Council has a priority for creating safer communities.

There has again been a countrywide lockdown during this quarter which has continued to result in much lower volumes of all priority crime categories and overall total recorded crime.

However, the easing of lockdown restrictions and the increased freedom of movement for residents over the next quarter is likely to result in increases in most priority categories.

The main risk area to the CSP remains violence without injury offences. This continues to be a result of malicious communications, harassment and stalking offences making up 47% of this offence type, with malicious communications accounting for almost a quarter (24%) alone.

Although the proportion of violence without injury offences that is domestic related has reduced to 39%, the volumes continue to be higher than last year. This is due to higher volumes recorded during the first lockdown and over the summer period.

Drug related violence with offences have tripled this year although volumes remain low. Of note, a third of the offences this year occurred in the last two months of this quarter suggesting a possible emerging issue.

Other sexual offences continues to show increases compared to the previous year, although this is in small volumes and is largely due to raised volumes between May and July 2020. Historical reports during this 12 month period account for 23% of all reports.


Hate offences and crimed incidents have significantly increased compared to last year and this is a countywide trend. In the borough there have been consistently higher volumes of reports throughout the 12 month period. It is has been suggested that the pandemic and associated restrictions has led to a general lack of tolerance amongst residents which may have manifested itself as hate crime, as well as increased awareness due to global events.

The increases in ASB (Non COVID-19 related) reports is largely due to higher volumes during the summer months. With seasonal trends and the easing of restrictions copingielingofores the next 2 quarters, it is likely that reports will remain high in the borough.

Total recorded crime levels have seen reductions during the previous 12 months, most notably in the second half of the year. This continues to be a direct result of the restrictions due to the COVID-19 pandemic.

With restrictions now easing, it is likely that 'typical trends' will resume with a possible 'surge' in offences over the next two quarters. This is as residents return to 'normal' lifestyles, providing more opportunities for offences to occur.

With a lockdown in place during this most recent quarter, violent crime has followed expected trends of lower volumes in quarter 4, due to limited opportunities for offences to occur.

Alcohol related violence has seen slight increases which is likely to have been aggravated by continued lockdown conditions. However, with drug related violence also an identified area of concern on page 1, this may suggest an emerging issue of **violence linked to substance misuse** and is highlighted here as an area of note to the CSP.






Serious Acquisitive Crime (SAC) 12 month rolling trend chart

Vehicle crime has reduced during quarter 4, although thefts of vehicle remain at higher volumes than quarters 1 and 2.

Residential Burglary (Dwelling) has seen a slight increase this quarter compared to quarter 3, although volumes still remain very low.

Personal Robbery is highlighted as a possible area of note to the CSP due to the raised volumes in quarter 4.

Seasonally **serious acquisitive crime** gradually increases towards the end of quarter 2. However, with pandemic restrictions easing during quarter 1, this is likely to lead to more people traveling around and into the borough for work and leisure purposes, providing more opportunities for offences to occur over the next 2 quarters.

KSIs continue to stay consistent despite the introduction of lockdown in January 2021. The easing of restrictions over the next quarter is likely to result in more traffic around the borough and the associated likely increase in KSIs. Risks of prolonged absences from driving (such as being 'out of practice', having poorly maintained vehicles, and also some drivers having taken advantage of empty roads to drive at speed around the local area) may also lead to increased incidents over the coming quarters.

Rural Crime

An increase has been seen in quarter 4 and could possibly be linked to the lockdown introduced in January 2021, where offences saw a 50% increase (+10) in January 2021 alone.

As highlighted in the Strategic Assessment 2021/22, restrictions linked to the pandemic this year has led to more people frequenting rural areas for exercise. This is likely to have impacted on rural crime with more offences being noticed and reported, and more opportunities for offences to occur. It is not clear what the long term trend will be in terms of whether more residents will continue to make use of rural areas as restrictions ease.

Positive areas:

- Total recorded crime has been lower during 2020/21 than in 2019/20 in almost all wards. This is a direct result of the COVID-19 pandemic restrictions in place during this year. It is evident that the three wards showing increases (Baddesley and Grendon, Atherstone Central, Hurley and Wood End) is due to increases in violence against the person offences in these areas.
- The **North SNT** area is the only SNT area to show reductions in **violence against the person offences** (-1 offence). This is largely due to reductions of -17 offences in **Polesworth West Ward**.
- Atherstone North and Hartshill Wards saw the largest reductions in violence against the person offences.
- Almost all wards have seen reductions in SAC offences, with Curdworth Ward showing the largest reduction (-54 offences).
- The East SNT area is the only SNT area to see reductions in non COVID ASB incidents (-55 incidents).

Areas of concern:

- The West SNT area saw the largest VAP increase of +41 offences, with Curdworth Ward showing the largest volume increase of +17 offences.
- The South and West SNT areas showed the largest volume increases in non COVID ASB incidents (+106 and +94 incidents respectively). Arley and Whitacre and Hurley and Wood End Wards were the main risk areas here, although Dordon Ward in the North SNT area also saw a large volume increase (+43 incidents) and is of note.

Introduction

This partnership plan has been prepared by the North Warwickshire Community Safety Partnership to help set out the objectives and aims of the partnership for the 2021/22 year.

This is intended to inform residents, parish and town councils, and other stakeholders including the Warwickshire Police and Crime Commissioner of the specific actions the partnership will carry out during the forthcoming year.

Our vision for the borough is:

"North Warwickshire; a community of communities. A place where people want to live, work and visit, now and in the future, which meets the diverse needs of existing and future residents, is sensitive to the local environment, and contributes to a high quality of life. A place which is safe and inclusive, well planned, built and run, and offers equality of opportunity and good services for all."

Foreword by Councillor David Reilly

Chair of the North Warwickshire Community Safety Partnership and the Borough Council's Safer Communities Sub Committee.

What a year we have had! Covid has certainly impacted community safety across North Warwickshire. The move to working from home has undoubtedly seen a reduction in acquisitive crime, with less house burglaries and car crime. Unfortunately, we have also seen a rise in reports of domestic abuse and public place fly tipping.

We very much expect 2021/2022 to be year spent returning to pre-Covid normality, normality in terms of social movement and cohesion; but also, normality in terms of pre-Covid crime and disorder incidents. Our task is now to do all we can to preserve the reductions in key crime and disorder incidents we have seen during the last year.

As a Community Safety Partnership, we are committed to working together to reduce crime and disorder across North Warwickshire. Our goal is to ensure that North Warwickshire remains a healthy, happy, prosperous and safe place to live, work and visit.

We are a multi-agency partnership and we work together to focus our shared efforts and assets to protect vulnerable people and places, prevent and rehabilitate offending behaviour, and importantly to empower local communities to tackle local problems.

This plan sets out our priorities for the coming year up to April 2022. They are based on the findings of the North Warwickshire Community Safety Partnership Strategic Assessment for 2021/22. We have set ourselves challenging priorities to protect our people and communities from violent crime, make our roads safer, prevent and reduce crime in our rural communities, and to prevent and help the police detect house burglary, vehicle crimes and robbery.

Our Priorities

North Warwickshire is a low crime area. However, we do experience crime and disorder problems and as a result the fear of crime amongst residents is often higher than we would hope.

Considering the findings of the North Warwickshire Strategic Assessment 2021/22 the following priorities for the year 2021/22 have been agreed by the North Warwickshire Community Safety Partnership;

Core Priorities

Violent Crime

With a focus on knife crime, domestic violence and alcohol related violence.

Serious Acquisitive Crime

With a focus on residential burglary dwelling, vehicle crime and personal robbery.

Rural Crime

Based upon the rural and wildlife crime strategy definition.

Road Safety

With a focus on traffic accidents resulting in killed and serious injuries.

Cross Cutting Themes

There are cross cutting themes which we consider represent a risk to community safety in North Warwickshire. These are:

- Vulnerability and Exploitation Activities to reduce individual and community
 vulnerability are a golden thread that weaves through all of our planning and
 interventions. Key amongst our interventions are: Protecting people from harm;
 tackling county lines drug dealing; and other reducing and mitigating risks associated
 with serious organised crime groups.
- Reducing Re-Offending The partnership will support the Warwickshire Reducing Re-Offending Strategy. Our aim is to stop offenders from committing crime by supporting a multi-agency enforcement activity and ensuring that all offenders can easily access support services to enable them to tackle problems of drug and alcohol addiction, homelessness, benefits, and access to employment and education.
- Improving Public Perceptions of Safety The partnership will work to protect local communities from harm and empower individuals, parish councils and communities to protect themselves. We will also promote positive community safety and crime prevention communications whenever possible. This will follow the steer from research carried out by the National Policing Improvement Agency which shows that information about crime and policing positively informs and influences public perceptions about crime within their neighbourhoods.

Areas of Concern

Areas of concern are issues that have been identified as emerging issues. They are actively monitored by the partnership:

- Hate Crime the partnership will support the county wide approach to tackle hate crime through the work of the Warwickshire Hate Crime Partnership.
- Prevent the partnership will support the county wide approach to the Prevent strategy.
- Anti-Social Behaviour the partnership will monitor and where necessary respond
 to personal, nuisance and environmental anti-social behaviour including deliberate
 small fires.

Our Objectives

The North Warwickshire Community Safety Partnership will work to follow a partnership problem solving approach to deliver local projects and initiatives to address the priorities within this partnership plan by supporting and facilitating the delivery of the following objectives:

Violent Crime

- Coordinating a joined-up approach to problematic licensed premises through a multi-agency Licensing Enforcement meeting
- The provision of counselling services for victims of domestic abuse
- Working to enhance the signposting to and access to local and county wide domestic violence support services
- Identify ways to prevent increases in homelessness because of domestic violence.
- Working with young people to consider the prevention and early identification of vulnerable young people likely to be exploited by county lines activity in line with the Government's Serious Violence Strategy.
- Championing and raising awareness of safeguarding and protecting vulnerable people
- Promoting awareness of the risks associated with alcohol and drug misuse
- Work with drug and alcohol treatment service providers to increase the numbers of those in treatment for substance misuse
- Raising awareness of the role of the Blue Sky sexual offences centre and support available to victims

Anti-social behaviour

- Reducing the risk of harm to vulnerable people and repeat victims of antisocial behaviour by implementing multi agency case management plans
- Working with young people to reduce the risk of them engaging in antisocial behaviour by supporting positive diversionary activities
- Working with local communities to help reduce incidents of motorbike nuisance including implementing environmental security measures and promoting the "Dob em in" reporting initiative
- Promoting awareness of the risks associated with alcohol and drug misuse to young people and their parents and signposting local support and treatment services
- Target hot spot locations to address the causes of anti-social behaviour

- Deploying mobile CCTV cameras at priority locations to provide public reassurance and prevent incidents of anti-social behaviour and identify perpetrators
- To support the enforcement of the Street Cruising Injunction across the Borough and prepare for a review of the use of the Injunction.
- To reduce the incidents of fly tipping within the borough and to investigate incidents with the aim of prosecuting those responsible
- To review how the ECINS system can be used more effectively.,

Crime in Rural Areas

- Reducing the risk of repeat victimisation of all burglary victims in priority locations through the provision of crime prevention advice and security measures
- Reducing the risk of repeat victims of theft from vehicles in priority locations through provision of crime prevention advice and security measures
- Target hardening priority locations to make crime harder to commit and to identify those responsible
- Working with local communities to encourage participation in Neighbourhood Watch and Rural Watch

Road Safety

- To work in partnership with the Warwickshire Road Safety Partnership, to reduce the numbers of killed and serious injuries on our roads with a focus on vulnerable groups.
- To support the improving road safety action plan prepared by North Warwickshire Borough Council
- To ensure the best road safety education is delivered to all school children within our borough
- To raise awareness of the dangerous locations and times where serious injury and fatal accidents happen
- To work with Highways England and Warwickshire County Council to reduce vehicle speed and improve road and junction design to make dangerous locations safer including due consideration of relevant planning decisions
- To prevent the dangerous anti-social use of motorcycles, cars and other vehicles both on road and off road across our borough

Reducing Re-offending

- Effectively supporting and contributing to the "One Day One Conversation" Integrated Offender Management Scheme for the identified offenders from North Warwickshire
- Support the implementation of the Warwickshire Reducing Reoffending Strategy and action plan
- Supporting the County wide arrangements for offender engagement with and retention in drug and alcohol treatment services
- Reducing offending by cross border offenders committing serious acquisitive crime by maximising the use of the network of automatic number plate recognition cameras within the borough to analyse and share intelligence to inform targeted policing operations

Hate Crime

- Support the Warwickshire Hate Crime Partnership and the county wide hate crime action plan
- Monitor reported incidents of hate crime to ensure appropriate partnership responses are put in place.

Prevent

- Support the Prevent Officer to raise awareness of Prevent
- Signpost training opportunities for relevant staff
- Support the work of the Prevent action plan and referrals to the local Channel Panel

Public perception of crime

- To further consider and arrange additional research into the North Warwickshire findings of the Have Your Say on Community Safety survey
- Arrange additional consultation in the areas of Kingsbury, Curdworth and Water Orton wards to establish the reasons for the high fear of crime results in these areas.
- To arrange and support positive crime prevention and community safety related communications using a range of methods and information

How We Protect Our Community

The partnership includes all the named responsible authorities including North Warwickshire Borough Council, Warwickshire Police, Warwickshire County Council, Warwickshire Fire and Rescue Service, National Probation Service, Warwickshire & West Mercia Community Rehabilitation Company and other partners.

The work of the Partnership is overseen strategically by a North Warwickshire Responsible Authorities Group.

How is the partnership organised?

Partnership activity is carried out at both a district and county level through several existing groups and arrangements. At a district level a North Warwickshire Responsible Authorities Group provides leadership and strategic direction in a local context. This group oversees the work of several operational groups that are set out below:

North Warwickshire Partnership Problem Solving Group: This group focuses on our higher volume crimes including violent crime, vehicle crime, business crime, domestic burglary, anti-social behaviour incidents and other specific crime types. The group follows a problem solving approach to consider emerging trends and current problems.

Rural Crime: Significant work has been carried out to support and enhance a Warwickshire Rural Watch Scheme. A Rural Crime Team is now established within Warwickshire Police. This is a direct result of building upon the success of the Rural Watch Scheme and the development of the Rural Crime Officer role. The Rural Crime Officer, with support of Warwickshire County Council Community Safety Team and the Police, manages the Rural Watch scheme and the schemes website. The website provides an extensive range of crime prevention and target hardening advice which is an excellent crime prevention tool. The Community Safety Team help to identify crime trends and patterns in the rural communities to supplement the work of the Rural Crime Officer as necessary.

Automatic Number Plate Recognition Cameras: Cross border offenders are believed to be responsible for the clear majority of the crimes in our rural wards and the ANPR cameras are providing real-time intelligence to identify and prosecute offenders who target our rural communities. A annual review carried out by Warwickshire Police shows that the cameras deployed in North Warwickshire are deployed for a pressing social need in line with the recommended surveillance camera commissioner guidance.

Arson Reduction: Warwickshire Fire & Rescue Service carryout patrols in rural locations to prevent small deliberate fires and anti-social behaviour. The Bike Team patrols are carried out over the summer months and during the time around Bonfire night and Halloween. Teams of fire-fighters working with PCSO's to patrol hard to reach areas to engage with young people and members of the local community using cycles.

Vulnerable Victims Case Management Group: This group was set up in 2013/14 to oversee individual case management plans for identified vulnerable victims. Risk Assessments for repeat victims are carried out and high risk cases are subject to specific case management plans. The group includes representatives from the Responsible Authorities and other partners including Victim Support, Registered Social Landlords and health services when necessary.

One Day One Conversation Integrated Offender Management: The Integrated Offender Management Group is a multi- agency scheme to help reduce the reoffending of identified offenders who commit a disproportionately large amount of crime. The requirements for the scheme are part of the statutory responsibilities of Community Safety Partnerships. The role of the group covers a wider Integrated Offender Management role to help respond to duties to reduce reoffending.

Multi Agency Action Planning: Specific multi agency meetings are arranged as necessary to identify actions to address the community priorities agreed through Safer Neighbourhoods and specific problem solving plans.

Domestic Abuse Emerging Trends: A county wide multi agency group meets monthly to consider emerging trends relating to domestic abuse incidents and crimes. A performance report is prepared which includes monitoring of violent crime offences related to domestic abuse, key business measures, repeat victims and other indicators showing performance related to support services and management of risk.

Northern Warwickshire Domestic Violence Forum: The Domestic Violence Forum is a multi-agency forum arranged jointly with Nuneaton and Bedworth Borough Council and the voluntary sector to help improve support services for victims of domestic abuse. The Community Safety Partnership in conjunction with the Council's Housing Division helps provide additional support services provided by the Warwickshire Domestic Abuse Counselling Services which seek to improve access to support services for residents.

At a county level, there are also a number of partnership arrangements which contribute towards the locally based activity and local strategy. The Safer Warwickshire Partnership Board supports the following county wide arrangements:

Warwickshire Reducing Reoffending Board: This board is a partnership group to oversee the implementation of a Warwickshire Reducing Reoffending Strategy and action plan. The group considers the seven identified pathways for reducing reoffending. The pathways include:

- Employment, training and education
- Accommodation
- Health
- Drugs and alcohol
- Finance, benefits and debt
- Children and families
- Attitude, thinking and behaviour

Drug and Alcohol Management Group: A multi-agency group to co-ordinate partnership activity aimed at reducing the impact of alcohol and drug misuse across Warwickshire.

Community Safety Officers Group: This partnership group meets to help share good practice and shared objectives between partners.

Youth Justice Management Group: The Warwickshire Youth Justice Service is a multidisciplinary team which works in partnership with other teams and agencies including Social Care, Probation, Police, Education and Careers and health. The Youth Justice Service (formerly the Youth Offending Service) works with young people aged between 10 and 17 years who have offended or are likely to do so. The Youth Justice Service aims to prevent young people offending and works with young people, parents and victims of crime.

Warwickshire Road Safety Partnership: This is a partnership working to reduce road deaths and injuries. The partnership includes Warwickshire County Council, Warwickshire Police, Warwickshire Police & Crime Commissioner, Warwickshire Fire and Rescue, Community Safety Partnerships and the Warwickshire Association of Local Councils.

Serious Organised Crime Joint Action Group: This county wide group has been set up to develop wider partnership working to help address specific identified individuals with links to serious organised crime groups who operate in Warwickshire. Specific multi agency action plans are prepared with the aim of taking co-ordinated action when the opportunity arises.

North Warwickshire Improving Road Safety Action Plan Progress Report

1 Summary

1.1 This report provides Members with an update on the progress with the North Warwickshire Road Safety Action Plan. The report also outlines recent road safety developments and feedback from the Warwickshire Road Safety Partnership Operational Board held in April 2021.

Recommendation to the Sub-Committee

- a That Members note the report and consider the progress made to date; and
- b That members consider the interim presentation slides prepared for the proposed Warwickshire Road Safety Strategy and identify any feedback they wish to make to the Road Safety Partnership Operational Board.

2 Consultation

2.1 Consultation has taken place with the relevant Members and any comments received will be reported at the meeting.

3 Background

- 3.1 A North Warwickshire road safety action plan was agreed by this Sub-Committee at a meeting held on the 16 March 2016.
- 3.2 The action plan is attached at Appendix A and includes updates showing the current position with progress to date.
 - 3.3 Progress with the action plan is challenging and requires further development with partners, including Warwickshire County Council, Warwickshire Fire and Rescue Service, Warwickshire Police and others. Warwickshire County Council is the lead authority for road safety in Warwickshire. At a local level, road safety is being championed by the Council and it is also one of the priorities for the North Warwickshire Community Safety Partnership. The work starting to emerge from the Warwickshire Road Safety Partnership is

encouraging and is developing more collaborate work to improve road safety in Warwickshire.

4 OPPC Road Safety Grant Funding

- 4.1 Members were previously informed about the receipt of a road safety grant from the Warwickshire Police and Crime Commissioner. The grant of £2,880.00 to the North Warwickshire Community Safety Partnership was towards a bid to increase the provision of Bikeability in North Warwickshire schools.
- 4.2 The project has been delayed due to the COVID 19 lockdown and restrictions. The aim was to offer the sessions to the schools from January 2021. Due to the ongoing COVID 19 lockdown restrictions no progress has been possible with the project. Discussions have taken place with the Office of the Crime and Commissioner about carrying over the grant funding into the 2021/22 financial year.

5 North Warwickshire Community Speed Watch

- 5.1 The management and oversight of supporting the Community Speed Watch Schemes is now fully based with Warwickshire Police. A newsletter has recently been prepared to inform the speed watch groups and stakeholders about how the schemes will be supported and developed. A copy of the newsletter is attached at Appendix B.
- 5.2 As part of the reintroduction of the schemes volunteer administrators are being sought. The interview process is currently taking place for the volunteers.
- 5.3 Allied to the Community Speed Watch Schemes a new sub-group of the Road Safety Partnership has been set up to consider speeding concerns across Warwickshire. This group will focus on speeding in Warwickshire, resident's concerns about speeding and performance of speed management. The subgroup is chaired by Chris Lewis an officer from the Office of the Police and Crime Commissioner. The Policy Support Manager is a member of the subgroup along with representatives from Warwickshire County Council, Warwickshire Police and the Warwickshire Association of Local Councils. The first meeting of the sub-group was held in March.
- 5.4 The Speed Working Group is developing its terms of reference and aims to achieve "A year on year reduction in the number of killed and serious injured collisions which have speed as a contributory factor, working toward vision zero." This shows a commitment to vision zero and can then be altered to be line with the benchmarks set by the partnership strategy, which is being developed currently.
 - 5.5 The group is currently considering some research by the Road Safety Coordinator on a partnership central reporting system for speed concerns and looking into how other parts of the country run this. Three distinct examples from Lancaster, North Yorkshire, and Devon have been identified.

6 Warwickshire Road Safety Partnership

- 6.1 Members were previously informed about the re-establishment of the Warwickshire Road Safety Partnership and the setting up of a Joint Strategic Board and a Joint Operational Board. A key action for the partnership is the preparation of a Warwickshire Road Safety Strategy. Attached at Appendix D is a copy of presentation slides showing some interim points identified by the Consultants commissioned to prepare the strategy. Members are asked to consider the comments included in the slides and highlight any feedback they want to provide to the Operational Board.
- 6.2 The most recent meeting of the Operational Board was held in April 2021. The Policy Support Manager is a representative at the Operational Board. The key feedback from the April meeting includes the following:

April 2021 Meeting

- Agilysis have been commissioned to prepare a Warwickshire Road Safety Partnership Strategy. Consultation regarding the strategy with partners is being arranged.
- Road Safety Partnership Grant and Finances a bid for additional signage for P2W on rural and ANPR routes has been agreed. A bid from the North Warwickshire Safer Neighbourhoods Team for additional speed warning signs in Ansley Common was not approved. Further work and discussions on a bid from Fillongley Parish Council is taking place.
- Discussion held about current initiatives to improve road safety with young people. The initiatives highlighted included:
- Think Team launching their good driver campaign on the 2 June 21.
- At a national level research is being carried out by Elizabeth Box and the RAC foundation, they are leading on the Pewter (theatre in education) review. Also 'running Driver 2020' there is a large research study in this area looking at novice and learner drivers. Feedback on Novice will hopefully be end 2021. Learners will be another two years (2023). Both programmes delayed by the COVID 19 restrictions.
- The Office of the Police and Crime Commissioner has agreed a grant to the organisation First Car to do more work with the concept they have called The Honest Truth. This is developing and includes funding magazines that First Car produce to go into the young driver/rider audience.
- The Fatal Four programme is still available and is planned to be reestablished in schools.
- Police are working with the Road Safety Education team. A lot of initiatives with young people are Warwickshire County Council led. The Safer Neighbourhood Teams have produced joint assemblies and lots of activity at local level previously.
- Plans to support the national drink driving campaign in August 22 29.
- Initiatives for the Summer Biker season include Biker Down event at Ragley Hall. Warwickshire Police Bike Safe campaign has been launched up until end of July. The 2 Wheels Campaign includes a video on Bike Safe this has reached 30,000 people. Bike Down is being promoted on social media. Engaging with bikers through the campaigns on speed in August and

- vulnerable road users in September. The scope to engage with the Bikers meets at Bassetts Pole was raised.
- National Young Riders Forum focused on supporting young riders aged 16 to 24 years who ride motorcycles of less than 125cc. One of the benefits of NYRF is that individuals can still promote local schemes which can also be shared and promoted by other forum members. Forum members are asked to contribute a minimum of £1,000.00. This pays for facilitation and project management, the NYRF website and social media platforms. Group agreed for Warwickshire to join.
- Representatives from Agilysis provided an outline of their proposed development of a road safety strategy for Warwickshire.
- Strategic Board approved an organisation Bread and Butter to develop a Warwickshire Road Safety Partnership website subject to clarification of longterm hosting costs. Launch of the website for partners use will be arranged.
- Recent communications work highlighted the following E-scooter media reached 80,000 views with 400 comments 150 shares and 200 likes. Biker Safe and Biker Down reached 30,000 with 18 likes, the Bike Safe Video clip had 3,500 views. Work on educating young people about cycle safety. This was a huge success reaching 15,000 on the police account alone.
- Road Safety Ambassadors are being sought initially from the Police and people who have contacted to promote road safety. The Rural Crime Officer is now an ambassador for horse related road safety issues.
- NDORS courses. 5,000 more clients then last year and employed two staff. No update on when classroom courses will start again.
- North Warwickshire Street Cruising Injunction review highlighted.
- Nationally the notice of prosecutions is being changed to be simpler, going live 10 May. This includes a talking head video with information. Warwickshire Police are exploring having a proactive arm for the unit and recruit special constabulary for this. The team could then be deployed into the community to do speed enforcement or education.
- It was proposed to set up a partnership working group to focus on school parking across the county.

6.3 Warwickshire Roads Policing Team

6.3.1 Attached at Appendix C is the latest Warwickshire Roads Policing Team June 21 newsletter. The newsletter shows several initiatives, information about news stories relating to road safety across Warwickshire.

7 North Warwickshire Action Plan Updates

- 7.1 The updates to the action plan are shown in the appendix and some key updates highlighted below:
 - The levels of the number of people killed and serious injuries is decreasing currently, with 43 in 2019/20 and 40 in 2020/21. There were 5 fatalities in 2019/20 and 1 in 2020/21.
 - Street Cruising Injunction in place until 22 June 2021. A judgement has been made about a challenge raised relating to injunctions against persons unknown. The judgement is currently being considered. This will

- impact on the review of the Street Cruising Injunction. Legal advice will be sought about the implications and options for future use.
- Road safety considerations are continuing to have a higher profile in determining planning applications.
- The Warwickshire Road Safety Partnership and the appointment of a Road Safety Co-ordinator is helping to gain some momentum to improve partnership working on tackling road safety concerns.
- Road safety is still an ongoing agenda item for the A5 Transport Strategy Group.

8 **Summary**

8.1 Members are requested to note the progress made to date and consider the feedback from the Warwickshire Road Safety Partnership Operational Board, and the updates included in the report.

9 Report Implications

9.1 Financial Implications

9.1.1 Additional expenditure on road safety may be required if specific projects and initiatives are developed. Any future expenditure will need to be allocated from existing Corporate Policy and Safer Communities ear marked reserves.

9.2 Safer Communities Implications

9.2.1 These are set out in the report and appendix.

9.3 Environment and Sustainability Implications

9.3.1 By working to improve road safety in the Borough, this will contribute positively towards improving the quality of life and safety of local people and visitors to North Warwickshire.

9.4 **Health Implications**

9.4.1 The work of the Road Safety Partnership will have crossover links which will contribute towards healthy communities including reducing deaths and injuries and preventing alcohol and drugs misuse.

9.5 Risk Management Implications

9.5.1 Road Safety on a Warwickshire level is improved through partnership work of the Warwickshire Road Safety Partnership. The partnerships include Warwickshire County Council, Warwickshire Fire and Rescue, Public Health, Community Safety and Road Safety Teams, Office of the Police and Crime Commissioner and Highways England.

9.6 Equality Implications

9.6.1 Some of the road safety campaigns and education programmes will be targeted for groups including young people and vulnerable people.

9.7 **Legal Implications**

As briefly referred to in the Action Plan, a recent decision of the High Court impacts significantly on how injunctions are obtained against people whose identity is non known. The Council must carefully consider the approach it takes in future cases and is seeking external advice on the issue. Further advice will be given to the Sub-committee as to the options available to deal with the issue.

9.8 Links to Council's Priorities

9.8.1 Road Safety is included as a priority for the Council as part of the Creating Safer Communities priority.










All casualties trend




PRINCIPLES OF THE SAFE SYSTEM


1. People make mistakes that can lead to road crashes

2. The human body has a limited physical ability to tolerate crash forces before harm occurs

3. A shared responsibility exists amongst those who design, build, manage and use roads and vehicle and provide post-crash care to prevent crashes resulting in serious injury or death

4. All parts of the system must be strengthened to multiply their effects; and if one part fails, road users are still protected.
