• This may mean that in exceptional circumstances SNT officers may be required to work on other policing priorities.


• If this happens there will be a need to re-negotiate priorities. This will be done in liaison with the Chair and the panel.

ASB – Coleshill Town Centre

- 26 targeted patrols have taken place specifically to combat ASB
- Alcohol has been seized from young people on 2 occasions.
- 10 visits have been made to Coleshill High School for talks aimed at ASB including Halloween and Bonfire night.
- 5 warning letter has been sent to the parents of one young person regarding his behaviour.
- Two Licensed premises have been the subject of a Licensing Review and one premises has been advised.
- Monthly checks made in Licensed premises and in some cases weekly.

ASB – Ansley Common, allotments.

- 30 targeted patrols made of the area.
- Site meeting took place between interested parties regarding ASB.
- Multi Agency meeting took place where an action plan was drawn up including the use of CCTV, leaflet drops, fencing and other improvements to the allotments, sourcing funding and evidence gathering to deal with offenders.
- 8 statements taken from local residents.
- Advice file forwarded to the ASB Officer for consideration of one ASBO.

- Alcohol seized from a number of youths on two occasions.
- A number of local youths stopped and spoken to and details obtained.
- Liaison maintained with local, Borough and County Counsellors together with other Agencies and local residents.
- Action plan ongoing

WHAT IS ANTISOCIAL BEHAVIOUR?

It's behaviour that causes alarm, distress or harassment to you, your friends and family. Examples include:

WHY REPORT IT?

Antisocial behaviour can ruin lives. Information you provide enables action to be taken.

TAKING ACTION

Action can be initiated by a number of agencies. This can include:

- Possession proceedings against a tenant
- Warning letters and interviews, contracts and agreements
- Fixed penalty notices and penalty notices for disorder
- Parenting orders, individual support orders, noise abatement notices, injunctions, dispersal powers and antisocial behaviour orders (ASBOs).

We need information in order to take action.

NUISANCE VEHICLES DON'T ACCEPT IT – REPORT IT

WHAT ARE NUISANCE VEHICLES?

Nuisance vehicles are those that are driven in a manner that causes or is likely to cause alarm, distress or annoyance to members of the public.

WHY REPORT IT?

Nuisance vehicles can ruin lives. Warwickshire Police will not tolerate this form of antisocial behaviour. Information you provide will enable action to be taken.



TAKING ACTION

Police can seize vehicles if drivers are issued a warning and are then caught again within 12 months driving in the following ways:

- On or off road in a manner that causes or is likely to cause alarm, distress or annoyance to members of the public. (Police Reform Act 2002, Section 59)
- Carelessly or inconsiderately. (Road Traffic Act 1988, Section 3)
- On land other than a road. (Road Traffic Act 1988, Section 34)

We need information in order to take action.

- Who is driving / riding the vehicle
- Where the vehicle is being used
- When it is being used
- The vehicle make, model and colour.

A school talk was given to the pupils of Nursery Hill Infant School, Ansley Common on the 15 October by PCSO Phil McGuinness, with regards to safety during Halloween and Bonfire Night. He also discussed the issues of wearing bright coloured clothing now that the darker nights are drawing in. With this in mind PCSO McGuinness gave the pupils florescent Road Safety Hedgehog stickers that they can wear on their coats and stick on the school bags. Halloween and Bonfire night safety leaflets were also given to the school to hand out to parents. On Tuesday, 03 November 2009, PC 649 Andy HOPKINS along with PCSOs Jane OWEN and Hayley Waller, visited several locations in Coleshill town where they distributed tamper proof number plate screws to numerous residents and gave general crime prevention advice. In recent months the town has been plagued with a number of incidents where number plates have been stolen from vehicles. This initiative to help combat this serious crime, coincided with the Neighbourhood Watch Association's "Not in My Neighbourhood Week". In total about 200 households were visited. • On Tuesday 03 November 2009 PCSOs Caroline McMURCHIE and Gavin SCOTT were joined by seventeen pupils from The Archbishop Grimshaw School in Chelmsley Wood for a graffiti clean up and litter pick at the Coleshill Skate Park and Cricket Club.

The litter pickers filled a whopping five bags of litter and the appearances of the skate park and Cricket Club were massively improved.

The clean up project was organised as part of the 'Neighbourhood Watch, Not in my Neighbourhood' initiative and was the closing session of a six week awareness programme that PCSO Caroline McMURCHIE had been working on with the school.

• PCSO MCMURCHIE has delivered talks on Gang Culture, Gun and Knife Crime, Drugs and Alcohol, Antisocial Behaviour and Criminal Damage to the pupils who have been working towards achieving their Prince's Trust Awards. On Wednesday 04 November 2009 PCSOs Phil McGuinness and Carl Boulter held Crime Prevention Surgeries as part of the NHW Association's "Not In My Neighbourhood Week" at the Rowland Court Community Centre in Old Arley and the Eastlang Road Community Centre in Fillongley.

• The PCSOs also hand delivered crime prevention advice leaflets to the elderly and more vulnerable residents in Rowland Court and Eastlang Road, who could not get to their respective local community centres.

On Thursday 26 November 2009, PCSOs Phil McGuinness and Carl Boulter and PC Paul Vaughton held a crime prevention day at the Co-Op and Premier Store at Gun Hill, New Arley. Also in attendance were North Warwickshire Fire & Rescue Service who gave out free smoke alarms and fire prevention advice, and representatives from Warwickshire CC and NWBC. Officers gave advice on crime prevention and NHW, with items on sale e.g., prikka strips/shed alarms/Smartwater. This event was also aimed at the recent spate of fires and criminal damage in the Arley area.

PCSOs Give Christmas Performance.

On Thursday 03 December 2009 at 03.00pm PCSOs, Pete Beale, Carl Boulter and Phil McGuinness held a festive sing-a-long and crime prevention event at Rowland Court, Old Arley for the elderly residents of the villages of Arley, Ansley and Fillongley. Also at the event were NWBC's Neighbourhood Wardens Debbie Fitter and Julie Richardson who kindly supplied refreshments. Pete Beale and Carl Boulter performed songs from the 40s, 50s and 60s era followed by a number of Christmas carols. At the end of the performance PCSO Phil McGuinness presented a talk to the elderly residents on crime prevention, focusing on distraction burglaries. The event was thoroughly enjoyed by all those who attended the event.

North Warwickshire pre Christmas Campaign

Aim

To protect residents from acquisitive & violent crime on the run up to Christmas the district will adopt tactics to impact positively upon these areas. PCSOs continue to visit the victims of all crimes to offer crime prevention advice and provide reassurance. Victims of dwelling burglary and surrounding vulnerable premises will be provided with burglary vouchers to improve security.

• Newsletters for each of our Forum Areas to be compiled and delivered to residential properties promoting crime prevention and public confidence messages. Anti drugs: Police working with Partners message to be highlighted in 'North Talk'

• PCSOs to conduct early morning patrols to advise regarding leaving cars running to defrost and presents and expensive equipment left in view. Op Strangford.

- PCSOs to conduct targeted patrols in response to crime analysis, to disrupt offences of dwelling burglary, autocrime and commercial robberies.
- Reintroduction of Operation Jaunt to tackle valuables left in cars on car parks across the area.
- Actively growing the North Warwickshire Good News E-mail Tree and promoting our community safety activity to build public confidence.
- Implementation of mini anti burglary or autocrime operations to address trends as they emerge. Op Strangford.
- Implementation of an anti violence campaign across Christmas and the New year to deter violence and detect assaults. Op Straban
- Crimes of violence to be actively directed and progressed by the crime advisor and staff on light duties.
