#### 1. Welcome from the Chair

Councillor Chris Clark welcomed everyone.

#### 2. Apologies and notes of last meeting

Minutes of 23 February 2016 meeting were agreed as a true record.

Matters arising:

- Introduction of Civil Parking Enforcement will require all signs and lines to be checked and updated including those in Market Street, Atherstone.
- A pedestrian crossing is planned outside Hartshill School
- Graffiti on A5 bridge and on Westwood Road railway bridge has been removed
- WCC Traffic & Road Safety officers do not have the capacity to attend Community Forums but can provide written responses to queries

#### 3. Police Update

Safer Neighbourhoods Team – PC Chris Bell presented a summary of progress and actions taken since the last Forum meeting.

The following comments were made:

- PC Chris Bell newly appointed to SNT East
- Atherstone Community Speed Watch minimum of 6 residents needed to run a training course and set up group. 3 residents required to do a speed check
- Hartshill Community Speed Watch 6 residents signed up more needed. PC Baxter to provide Speed Watch data to Cllr Henney
- Chapel End, Coleshill Road has two suitable locations for Speed Watch
- Chapel End, Coleshill Road group seen carrying butterfly knives
- Oldbury Road, Hartshill local resident litter-picked 20 bags of litter
- Church Walk / Rose Hill, Atherstone problems with ASB and vandalism of NWBC pavilion

- Manor Road, Mancetter speeding mopeds & 4x4s
- Castle Road, Hartshill speeding
- Hartshill fly-tipping in lay-bys
- Grange Road, Hartshill nuisance off-road motorbikes
- Carlyon Road, Atherstone speeding
- Mancetter off-road police bike covered in mud. Brake-light / lights not visible
- AVIVA Bike Race temporary Traffic Orders in place and designated parking areas

Three priorities were chosen:
