
Before HHJ Rawlings, sitting as a Judge of the High Court, on 7 March 2025;

UPON hearing Counsel for the Claimant and the Defendants not attending or being represented.

IT IS ORDERED:

1. Until 7 March 2030, nobody shall (whether by himself or by instructing or encouraging any other person) move any caravans, mobile homes, camper vans, structures (such as toilets) on to the Land for residential purposes or undertake development on the Land.
2. The Land referred to in this order is Cattle Market, Station Street, Atherstone Warwickshire, CV9 1DD ("the Land") as delineated in red on the attached plan.
3. For the avoidance of doubt, if a person unknown claims that s/he was unaware of the terms of this order when they breached it, they must remove any caravan/mobile home/camper van and vacate the site within 24 hours of being informed of the terms of the order. Otherwise, they shall be in contempt of Court.
4. The Claimant shall serve the Defendants by advertising the terms of this order on its website and affixing notices advertising the existence of the injunction with information as to how the terms may be accessed at two conspicuous locations at the entrance to the Land so that it comes to the attention of visitors.
5. Any party is at liberty to apply to discharge or vary this order upon 48 hours written notice to the Claimant.
6. The First Defendants shall pay the Council's costs to be assessed if not agreed.
