## **COUNCIL TAX DISREGARD GUIDANCE NOTES**

### PERSONS IN DETENTION

A person may be disregarded for the purposes of Council Tax Discount if he/she is detained:

- a) in a prison, a hospital or any other place by order of a court;
- b) under the Immigration Act 1971;
- c) under the Mental Health Act 1983; or
- d) under the Mental Health (Scotland) Act 1984.

A person will **<u>not</u>** be disregarded if he/she is detained:

- a) for non-payment of Council Tax;
- b) for default in payment of a fine; or
- c) only under section 407 of the Criminal Procedure (Scotland)
